ORCO Sportsman's Association, Inc. OUTDOOR RANGE RULES

- 1. THE RANGE SHOOTING HOURS ARE 0800 TO 1/2 HOUR BEFORE SUNSET. THIS DOES NOT INCLUDE YOUR SIGN IN/OUT OR SET UP OR BREAK DOWN TIME.
- 2. EYE AND EAR PROTECTION MUST BE WORN ON, AND NEAR THE FIRING LINE BY ALL SHOOTERS AND SPECTATORS.
- 3. NO TITLE II FIREARMS ARE ALLOWED WITH THE EXCEPTION OF LICENSED AND LEGALLY OWNED SUPPRESSORS AND SHORT BARRELED RIFLES AND SHOTGUNS. NO FIREARMS CAPABLE OF FULL AUTOMATIC OR BURST FIRE ARE PERMITTED. OWNERS OF SUCH ITEMS SHALL HAVE THEIR REGISTRATION DOCUMENT READILY AVAILABLE FOR INSPECTION.
- 4. NO FIREARM CHAMBERED FOR THE .50 BMG ROUND MAY BE USED.
- 5. HOLSTERED CARRY OF HANDGUNS IS ALLOWED.
- 6. THE SHOOTER IS RESPONSIBLE TO ENSURE THAT THE FIREARM IS SAFE TO FIRE AND THE AMMUNITION SAFE TO USE.
- 7. SHOOTERS MUST SHOOT ON THE APPROPRIATE RANGE FOR THE DISTANCE AT WHICH THEY ARE SHOOTING. THE 200-YARD RANGE IS FOR SHOOTING AT 200 YARDS ONLY. THE 100 YARD RANGE IS FOR SHOOTING AT 100 YARDS. ON THESE TWO RANGES, BACKERS ARE PLACED BETWEEN THE UPPER AND LOWER CROSS MEMBERS NOT ON THE VERTICAL SUPPORTS. THE 50-YARD RANGE MAY BE USED FOR SHOOTING AT TARGETS FROM 7 YARDS TO 50 YARDS. WHEN USING ANY TARGET AT ANY OF THESE DISTANCES, BE AWARE OF THE IMPACT AND PLACE THE TARGETS AT THE PROPER HEIGHT TO ENSURE BULLETS IMPACT DIRECTLY INTO THE BACKSTOP.
- 8. SHOOTING AT DISTANCES LESS THAN 50 YARDS MAY ONLY BE DONE ON THE 50 YARD RANGE. PLACE YOUR APPROVED TARGET FRAME IN THE HOLES CLOSEST TO THE BACKSTOP. POSITION YOURSELF FORWARD OF THE NORMAL FIRING LINE AT YOUR DESIRED DISTANCE FROM THE TARGET. NO ONE MAY SHOOT OR HANDLE FROM A POSITION BEHIND ANY OTHER SHOOTER
- 9. CLUB TARGET FRAMES, WHEN USED, ARE TO BE STORED PROPERLY. IF BUILDING YOUR OWN FRAMES THEY MUST CORRESPOND TO THE DIMENSIONS SHOWN IN THE ATTACHED ACCEPTABLE TARGET FRAME DRAWINGS.
- 10. TARGETS ALLOWED ARE ONLY PAPER, CARDBOARD AND STEEL (rule 10b).
 - a. DO NOT USE BOTTLES, GLASS, CANS, PLASTIC, BOXES, CEMENT BLOCKS OR OTHER JUNK THAT CANNOT BE CLEANED UP. OTHER TARGET MATERIALS MAY BE USED WITH APPROVAL OF THE BOARD DURING ORGANIZED EVENTS.
 - b. SPECIAL RULES REGARDING STEEL TARGETS:
 - FLAT STEEL TARGETS MAY BE USED ON ALL OUTDOOR RANGES.
 - THE TARGETS SHOULD BE PLACED AS CLOSE TO THE BACKSTOP AS POSSIBLE.
 - TARGETS SHALL BE OF THE APPROPRIATE GRADE OF STEEL FOR THE FIREARMS BEING USED.
 - TARGETS SHALL BE ON STANDS OR HANGERS AND MUST FACE THE SHOOTER.

ORCO Sportsman's Association, Inc. OUTDOOR RANGE RULES

- TARGETS MUST NOT HAVE DIVOTS, CRATERS OR PROTRUSIONS THAT COULD CUASE RICOCHETS.
- TARGET MANUFACTURER'S RECOMMENDATIONS, SUCH AS AMMUNITION USED, MINIMUM DISTANCE, SAFETY, ETC. MUST BE FOLLOWED.
- NO STEEL TARGETS MAY BE SHOT CLOSER THAN ONE HUNDRED (100) YARDS WITH A CENTER-FIRE RIFLE OR CLOSER THAN TEN (10) YARDS WITH A HANDGUN, PISTOL CALIBER RIFLE OR RIMFIRE FIREARM.
- ONLY LEAD, LEAD CORE OR FRANGIBLE BULLETS MAY BE USED.
- WHEN SHOOTING STEEL TARGETS, ALL OUTDOOR RANGE SAFETY RULES/PROCEDURES APPLY. THIS INCLUDES SAFE AND PROPER GUN HANDLING, EYE AND HEARING PROTECTION, ETC.
- 11. NO AERIAL TARGET SHOOTING OF ANY TYPE.
- 12. NO HUNTING OR SHOOTING OF WILD OR DOMESTIC ANIMALS, BIRDS, ETC.
- 13. NO SHOOTING OUTSIDE OF THE BACKSTOP AREAS.
- 14. COLLECT AND REMOVE ALL LITTER AND GARBAGE. KEEP THE AREA NEAT.
- 15. NO ONE IS TO GO FORWARD OF THE FIRING LINE UNTIL THE ENTIRE LINE HAS BEEN DECLARED SAFE ON <u>THAT PARTICULAR RANGE.</u> (50 YARD OR 100 & 200 YARD RANGES).
- 16. ALL FIREARMS ON THE LINE ARE TO BE UNLOADED, EITHER BENCHED WITH ACTIONS OPEN AND EMPTY CHAMBER INDICATORS IN PLACE, OR BOXED, CASED OR HOLSTERED WHEN SOMEONE IS DOWN RANGE. NO FIREARMS MAY BE HANDLED WHEN SOMEONE IS DOWNRANGE.
- 17. THE USE OF CHEMICAL AGENTS, TEAR GAS, CS, CN, DM, AND OC, PROPELLED BY ANY MEANS (HAND, GAS LAUNCHER, PEPPER FOG, SHOTGUN LAUNCHED) ARE FORBIDDEN.
- 18. NO EXPLOSIVE DEVICES ARE ALLOWED ON THE RANGE(S) AT ANY TIME.
- 19. WHEN TESTING A SEMI-AUTO FIREARM THAT WAS JUST REPAIRED, START WITH SINGLE SHOT ONLY. IF USING A RANSOM REST, USE SINGLE SHOT ONLY WHEN TESTING A SEMI-AUTO.
- 20. NO FAST DRAW FROM A HOLSTER OR UN-AIMED FIRING TYPE OF SHOOTING. UNDER NO CONDITIONS CROSSDRAW, SMALL OF BACK OR SHOULDER HOLSTERS ARE TO BE USED ON THE RANGE.
- 21. RULES MAY BE MODIFIED FOR A SPECIFIC EVENT, MATCH, OR OTHER REQUIREMENT, ONLY BY APPROVAL OF THE EXECUTIVE OFFICER OR BOARD.
